- The Gallery reproduces photographs on the Internet and in print for the purpose of promoting the exhibition and will not permit reproduction of the artworks included in the exhibition for commercial purposes.
- The Artist permits the Gallery to photograph the artwork for installation documentation and publicity, both in print and online (the Gallery's website includes a Creative Commons Attribution 4.0 International License).
- The Artist agrees that the artwork will not be removed from the Gallery until the assigned pick-up dates of March 28—April 1, 2023, 10AM — 5PM each day.
- The Artist agrees that the Gallery will retain a 30% commission on all artwork sales during the exhibition. If the artwork is not for sale, the Artist waives any exhibition fees that the Gallery would be obligated to pay.
- The Artist agrees to adhere to the guidelines outlined in the *Artist Entry Package*. Artwork that is deemed ineligible by the Gallery may not be included in the exhibition.
